I am writing in support of the Transportation Investment Generating Economic Recovery TIGER Grant application being submitted by the Crawford County Road Commission in Michigan.

Crawford County is home to Camp Grayling, the largest military training facility east of the Mississippi River. Military convoys and heavy equipment currently use the I-75 Business Route through downtown Grayling to access the base. The County will use this funding to upgrade the existing I-75/North Down River Road interchange from half to full access. A full interchange at this location would remove these vehicles from the main corridor, relieve congestion and enhance community mobility and safety.
