## **CRAWFORD COUNTY ROAD COMMISSION BID REQUIREMENTS**

All work must meet current Michigan Department of Transportation specifications.

Contractor shall provide Certificate of Insurance prior to commencing work. Certificate shall include:

- 1) **1) Board of County Road Commissioners AND the Crawford County Road Commission** named as additional insured to all coverage, **2) Bodily Injury Liability** – each person - \$500,000.00 each occurrence, **3) Bodily Injury Liability** – each accident - \$1,000,000.00, **4) Property Damage Liability** – each accident - \$1,000,000.00, **5). Single Limit Policy** - \$1,000,000.00 and **6) Worker's compensation-** statutory limits.

### **EQUIPMENT REQUIREMENTS**

The crushing machine shall be a self-propelled rotary reduction machine capable of crushing and mixing the bituminous pavement and underlying aggregate base to proper size and depth and shall meet the approval of the County Engineer. The machine shall have a positive depth control, which can be adjusted automatically. The cutting/mixing drum shall be enclosed and have the capability of sprinkling water in the mixing chamber to control pollution. The crusher may need to have bars or grizzlies installed to ensure proper sizing.

Payment shall be based on final field measurements.

The Crawford County Road Commission shall provide all traffic control and shaping.
