Jones Lake Road; From Wilcox Bridge Road northeasterly to Peters Road, 2.95 miles. T27N, R3W, sections 23, 27 and 33, Grayling Charter Township, Crawford County, Michigan.

General Specifications: Furnishing and Delivery of 23A Crushed Gravel

The Crawford County Road Commission shall be reconstructing the following roadway within the 2022 construction season:

Location: Jones Lake Road: From Wilcox Bridge Road northeasterly to Peters Road, 2.95 miles. T27N, R3W, sections 23,27 and 33, Grayling Charter Township.

Quantity: 9500 ton 23-A gravel.

Successful bidder shall coordinate Delivery dates with the Crawford County Road Commission.

Bidder is asked to provide a price per ton, for furnishing and delivery of 23A crushed gravel.

Bidder is to deliver into a stockpile at the job site, at which time, Road Commission forces will be placing material on the project's roadbed.

Bidder shall be limited to delivery times and days. Delivery shall be permitted between 7:00 a.m. and 3:30 p.m. Monday to Thursday, unless otherwise permitted by the Crawford County Road Commission.

Material must be from an approved source. Bidder shall supply the Road Commission certification of tested material per the current MDOT specifications prior to delivery. The Crawford County Road Commission reserves the right to collect and test for quality assurance from the Bidders stockpile.

Weight tickets must be provided for each load delivered to the job site, per current MDOT specifications.

All stockpiles are confined within the 66-foot-wide project right of way.

Project Completion Date: May 31, 2022, unless a different date is mutually agreed upon with the Crawford County Road Commission.

Contractor shall provide Certificate of Insurance prior to commencing work. Certificate shall include:

1) Board of County Road Commissioners **AND** the Crawford County Road Commission named as additional insured to all coverage, 2) Bodily Injury Liability – each person - \$500,000.00 each occurrence, 3) Bodily Injury Liability – each accident - \$1,000,000.00, 4) Property Damage Liability – each accident - \$1,000,000.00, 5). Single Limit Policy - \$1,000,000.00 and 6) Worker's compensation- statutory limits.

Crawford County Road Commission reserves the right to reject any or all bids, to waive irregularities in the bid, to waive details in the specifications, to add or delete quantities or projects to or from the bid and to accept the bid deemed to be in the best interest of Crawford County.
