NOTICE TO BIDDERS

The Crawford County Road Commission will receive sealed bids until 4:00 p.m. (for a bid opening during their regular meeting) on Thursday, March 30th, 2023 at their Grayling office located at 500 Huron Street, Grayling, MI 49738, for furnishing the following material:

23-A Crushed Gravel

Gravel to be made to Crawford County Road Commission specifications. Contractor will be required to furnish clay or any material deemed necessary to accommodate the specifications. Cost of furnishing these materials shall be incidental to gravel production. Material shall be produced and stockpiled at the following locations on or before June 1, 2023:

50,000 ton: within the proximity of T25N, R3W, Beaver Creek Township or T26N, R3W, Grayling Township.

15,000 ton: within the proximity of T28N, R2W, Lovells Township.

Specifications may be obtained by contacting the Crawford County Road Commission at the above address. Bids must be sealed in an envelope and clearly marked as "**23A Gravel Bid**".

The Board reserves the right to reject any or all bids, to add or delete quantities, to waive informalities in the bids and to award the bid deemed to be in the best interest of Crawford County.

23A Crushed Gravel Specifications

Gravel to be made to Crawford County Road Commission specifications. Contractor will be required to furnish clay or any material deemed necessary to accommodate the specifications. Cost of furnishing these materials shall be incidental to gravel production.

Road Commission Specifications for
23A Gravel

100% passing the 1" sieve
60-85% passing the 3/8" sieve
25-60% passing the No. 8 sieve
9-16% loss by washing

General

When fixed or radial stackers are utilized for stockpiling of dense graded, fine, coarse, and open-graded aggregate, the maximum height of material deposited by either type of stacker shall be 10 feet before the pile is leveled. Each layer of the material in the stockpile will be constructed by this method.

If Sand is to be removed prior to the crushing operation, it shall be screened in a fashion to produce 2NS sand and shall be placed in a separate stockpile. Such material shall become the property of the Crawford County Road Commission. Cost of screening and stockpiling shall be incidental to gravel production.

If stockpile is determined by the Road Commission to be segregated, it will be unacceptable for use.

Mineral Permits for the production of material on State of Michigan owned property will be procured (if possible) by the Crawford County Road Commission prior to production. Lovells Pit is owned and operated by the Crawford County Road Commission.

Bidder shall notify the Road Commission a min. of 5 days prior to commencing production. It is the intent of the Road Commission to supply inspection during production of aggregate.

Contractor shall provide Certificate of Insurance prior to commencing production. Certificate shall include:

1) Board of County Road Commissioners **AND** The Crawford County Road Commission named as additional insured to all coverage, 2) General liability- \$500,000 each occurrence, 3) Automotive liability- \$500,000 each occurrence, and 4) Worker's compensation- statutory limits.

Material shall be produced and stockpiled at the following location on or before June 1, 2023:

Proximity of T25N, R3W, Beaver Creek Township or T26N, R3W, Grayling Township.

Proximity of T28N, R2W, Lovells Township.
